The Directors of Discovery Africa Limited ("Discovery", "DAF" or the "Company") advise that further to the ASX announcement lodged on 7 February 2014, the Company provides the following update.

Namibia – Brandberg Lithium Project

The Brandberg Lithium Project is located some 60 kilometres South West of the town of Uis in Namibia. The Project comprises of six Mining Claims registered over the area known as the Karlowa Pegmatite Valley.

Phase 1 concentrated on the mapping, surface delineation and specifically determining potential mineralisation of the lithium bearing Pegmatites found within the Claims. The results were then used to determine a drilling program with borehole localities planned, in order to:

- Delineate the lateral and depth extents of the selected pegmatites
- Determine the orientation of the selected pegmatites below the surface
- Determine the pegmatites termination points
- Determine the pegmatite lithium quality and quantity down the hole

Currently 6 boreholes have been drilled totaling 325m of core. All pegmatite zones of the drill core will be sampled and the results of the sampling program will indicate the grades of lithium within the observed spodumene and amblygonite.

Drill core results will be announced once our technical team have reviewed them as part of the due diligence process.
